K33 safeguards your private keys by dividing and storing them across various secret locations, ensuring that only **K33** can authorize transactions involving customer funds. **K33**'s Transaction Authorization Policy ensures transactions can only take place after the required approval quota from a designated subgroup of employees is met, authenticating that a valid withdrawal request lies at hand.

Transactions are managed using the **Fireblocks** custody infrastructure (https://www.fireblocks.com/), without broadcasting your private keys. **Fireblocks** is the industry's most thoroughly audited and pentested platform for managing on-chain transactions. Their coverage includes professional liability insurance for errors and emissions (E&O) regarding assets in both storage and during transfer.

As an additional safety net, we use **CoinCover** (https://www.coincover.com/) to protect our clients' assets. **Coincover** is a Disaster Recovery Mechanism for extreme events and mitigates a range of additional risks associated with blockchain assets in unexpected scenarios (lost access, cyber threats, operational failure, technology failure).

Given that your assets are held on separate individual blockchain addresses, you can continuously monitor any transactions related to them using respective Blockexplorers, and even create alerts, for example using services like **QuickNode**: https://www.quicknode.com/quickalerts.






